- B. <u>Defensible Space</u>— David Manske / Liz Lawless / Matt Nunley/ Robin Kelley— David Manske gave an update on the Defensible Space program including a new form that includes the assessment form and home defense information which will be used for new assessments. There were 24 people who attended the zoom meeting. The training will be in April 2025. David Manske has the current list of those who are interested in being trained as assessors and he will add to this list if other people are interested in this training. David Manske stated that anyone who is interested will need to read the updated 90 page handbook before the training in April 2025.
